

NOTICE OF PUBLIC HEARING BEFORE THE CITY COUNCIL FOR THE CITY OF LACY LAKEVIEW,
TEXAS:

THERE HAS BEEN A REQUEST MADE BY 100% OF THE LANDOWNERS THAT THE CITY OF LACY LAKEVIEW ANNEX A CERTAIN TRACT OF LAND THAT IS CONTIGUOUS TO THE BOUNDARY OF AND LIES WITHIN THE EXTRA-TERRITORIAL JURISDICTION OF THE CITY OF LACY LAKEVIEW. THE TRACT OF LAND IS GENERALLY IDENTIFIED AS: CHEEMA PROPERTY, OUT OF THE SAMUEL BURTON SURVEY, BEING APPROXIMATELY 21.008 ACRES, MORE OR LESS, OF A CALLED 73 ACRE TRACT, EAST OF INTERSTATE 35 ON THE NORTH SIDE OF LACY LAKEVIEW. THE PROPOSED ZONING FOR THIS TRACT WILL BE AS FOLLOWS: AGRICULTURAL. A MAP AND DETAILED DESCRIPTION OF THE PROPERTY CAN BE VIEWED AT THE CITY SECRETARY'S OFFICE AT CITY HALL DURING NORMAL BUSINESS HOURS.
